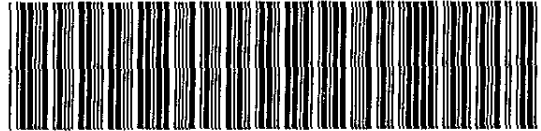



**ARTICLE I**

The name of this corporation shall be NEXUSARCHITECTURE, INC., and its principal office shall be 3703 W. Horatio Street, Tampa, Florida 33609
