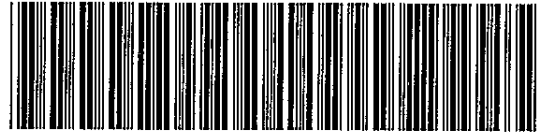

OF
