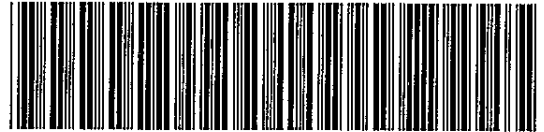

ARTICLES OF INCORPORATION

OF
