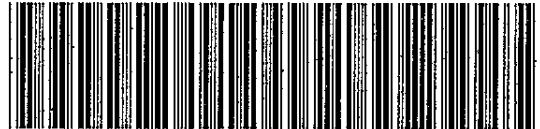

Preemptive Rights


