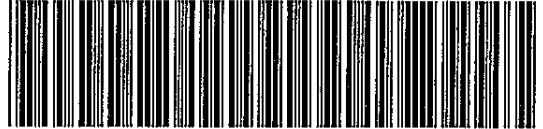

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned this day formed a corporation for the transaction of business, and the promotion and conduct of the objects and purposes hereinafter stated, under and pursuant to the laws of the State of Florida and we do hereby certify that:

**ARTICLE I
NAME**

The name of the corporation shall be: Walker & Son Pressure Cleaning and Painting, Inc.

**ARTICLE II
PRINCIPAL OFFICE**

**ARTICLE III
PURPOSE**

The nature of the business and objects and purposes proposed to be transacted, promoted or carried on by the corporation are to engage in any lawful activity.

**ARTICLE IV
SHARES**

The amount of the total authorized capital stock of this corporation is 10,000 shares without nominal or par value. Each share of stock shall have one (1) vote. 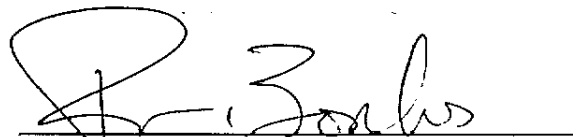
