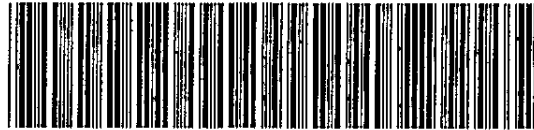

ARTICLES OF INCORPORATION
OF

ARTICLE I
Name

The name of the corporation shall be Florida Wireless Cable, Inc.

ARTICLE II
Duration

The duration of the corporation is perpetual.

ARTICLE III
Purposes

The general nature of the business to be conducted and transacted by this Corporation is the purchase, sale and installation of communication equipment and cable.

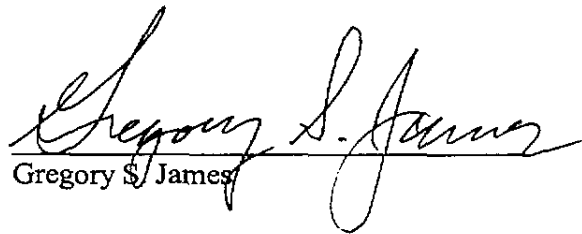

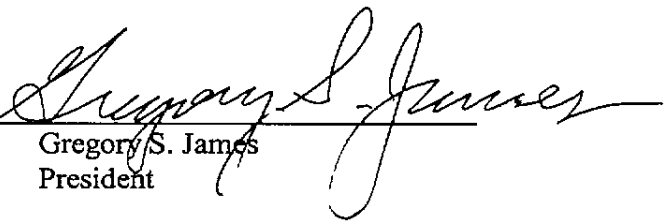

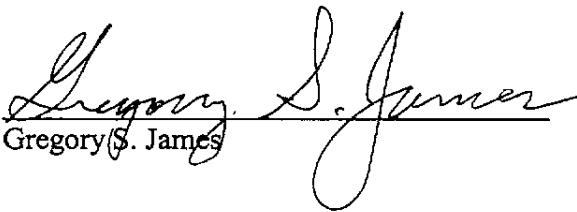
