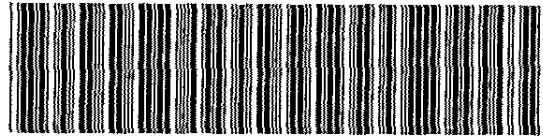

ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, acting as Incorporator of the FIRST QUALITY'S INSPECTION, INC., under Chapter 607 of the Florida Statutes, hereby adopts the following ARTICLES OF INCORPORATION for such Corporation.

ARTICLE I

NAME

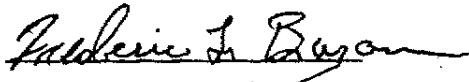
