ARTICLES OF INCORPORATION OF MILAGROS SUAREZ TAX SERVICES, INC

CERTIFICATE OF INCORPORATION MILAGROS SUAREZ TAX SERVICES, INC.

We, the undersigned, in order to form a Corporation for profit for the purpose hereinafter state, under the pursuant to the provision of the Florida Statutes, do hereby subscribed to this certificate of Incorporation, and do adopt the following Articles of Incorporation:

ARTICLES OF INCORPORATION

ARTICLE 1

The name of Corporation shall be: MILAGROS SUAREZ TAX SERVICES, INC.

ARTICLE II

The general nature of the business and the objects and purposes to be transacted and carried on by this corporation shall be:

- a. This Corporation is organized with the purpose to engage in tax services, and office related services and all other lawful related activities permitted under the laws of the State of Florida and the United States of America.
- b. To enter into, make and perform contracts of any person, firm association or corporation, town, city, country, state, territory or government.
- c.
