

ARTICLES OF INCORPORATION

OF



SAFE HARBOR FINANCIAL SERVICES OF THE TREASURE COAST, INC.

<u>ARTICLE I – NAME</u>

The name of this corporation is SAFE HARBOR FINANCIAL SERVICES OF THE TREASURE COAST, INC.

ARTICLE II – DURATION

This corporation shall exist perpetually.

ARTICLE III – PURPOSE

This corporation is organized to engage in the business, and to do all such acts and things as may be necessary or convenient to carry out the purposes intended by the organization of this corporation and, finally for the purpose of transacting any or all lawful business.

ARTICLE IV – CAPITAL STOCK
