ARTICLE I. NAME

The name of this corporation shall be GAYLORD, INC.

The power to adopt, alter, amend or repeal the Articles Of Incorporation of this corporation shall be vested in the shareholders by a majority vote of such shareholders.



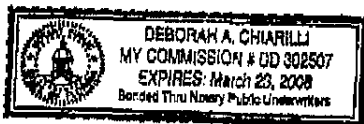
