#### ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following Articles of Incorporation:

## ARTICLE I. CORPORATE NAME.

The name of this corporation is: SINBAD'S PUB, INC.

## ARTICLE II. NATURE OF BUSINESS AND POWERS.

If all of the Directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidencing their consent are tiled with the Secretary of the corporation, the action shall be as valid as though it had been authorized at a meeting of the Board of Directors.
