

ARTICLES OF INCORPORATION MATTHEW L. BELL, C.P.A., P.A.

THE THE PARTY OF EST The undersigned incorporator to these Articles of Incorporation, being duly licensed to engage in business as a certified public accountant under the laws of the State of Florida, adopts these Articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, and other laws of the State of Florida.

ARTICLE 1 - NAME

The name of the professional service corporation is MATTHEW L. BELL, C.P.A., P.A.

<u>ARTICLE II - PRINCIPAL OFFICE</u>

The principal place of business is 3043 Shady Wood Lane, Lake Wales, FL 33898 and the mailing address of this corporation shall be Post Office Box 3466, Lake Wales, FL 33859-3466.

<u>ARTICLE III - PURPOSE</u>
