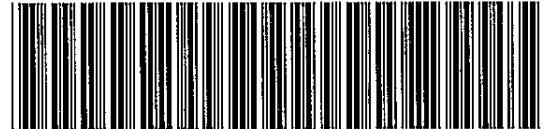

# **ARTICLES OF INCORPORATION**

The undersigned hereby agrees to organize a corporation in accordance with Chapter 607, Florida Statutes (the "Florida General Corporation Act") as follows:

#### **ARTICLE I. NAME**


