ARTICLES OF INCORPORATION

OF

DUSK KEY, INC.

The undersigned subscriber, a natural person competent to contract for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such corporation.

ARTICLE I

The name of this corporation shall be, Dusk Key, Inc.

Its principal office and mailing address shall be Post Office Box 516, Fort Pierce, FL 34950 or other place as may be designated, from time to time, by the Board of Directors.

ARTICLE II

The general nature of the business and the object and purpose for which the corporation is organized is to operate a business involving real estate and shall include the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.
