ARTICLE I
Name and Principal Office of Corporation

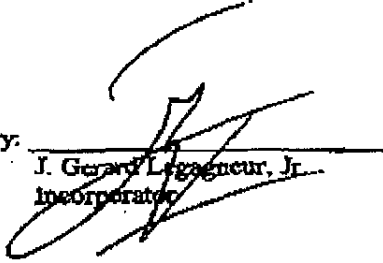

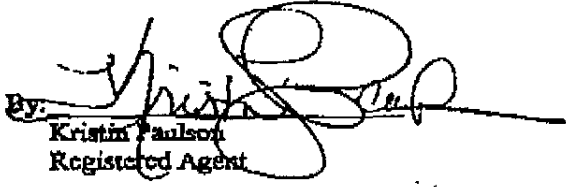
