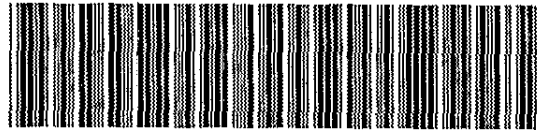

ARTICLES OF INCORPORATION

OF

ARTICLE I- NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **DEWAYNE'S SEAMLESS GUTTERS, INC.** and its principal place of business shall be located at **P O BOX 1312, Eagle Lake, FL 33839-1312.**

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV- CAPITAL STOCK

This corporation is authorized to issue **100** shares of common stock, with an assigned value of \$1.00 per share and shall designated as ACommon Shares.

ARTICLE V- PRE-EMPTIVE RIGHTS


