

ARTICLES OF INCORPORATION OF
SKC INSTALLATION, INC.

The undersigned, acting as Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

ARTICLE ONE

The name of this corporation shall be: **SKC INSTALLATION, INC.**

ARTICLE TWO

The purpose for which this corporation is formed is to engage in custom cabinetry & design. In addition to the above mentioned purpose, the corporation shall have the power to engage in any other business or activity permitted under the laws of the United States and the State of Florida.
