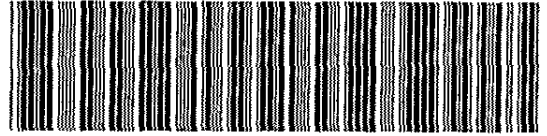

OF

ARTICLE 1

Name
