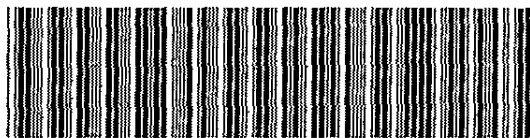

**ARTICLES OF INCORPORATION
OF

ARTICLE I- NAME

The name of this corporation is **CHRISTINE LASHIRE BAKER, P.A.**

This corporation shall exist perpetually, commencing on the date of signing.
