ARTICLES OF INCORPORATION OF FLORENTINO GONZALEZ, P.A.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation is FLORENTINO GONZALEZ, P.A. The mailing address of the corporation is 2973 N.W. 97th Court, Miami, Florida 33172.

ARTICLES II - GENERAL NATURE OF BUSINESS AND POWER

The general nature of the business to be transacted by this corporation shall be as follows:

This corporation shall have perpetual existence commencing on the date of execution and acknowledgement of these Articles of Incorporation.
