ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME.

The name of this corporation is: BUSINESS FORWARD, INC.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS.

The principal place of business and the mailing address of this Corporation, in the State of Florida shall be, 212 Lakeside Circle, Sunrise, FL 33326.

ARTICLE III. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE IV. CAPITAL STOCK.

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share.

ARTICLE V. TERM OF EXISTENCE.

This Corporation shall have perpetual existence.

ARTICLE VI. BOARD OF DIRECTORS.

This Corporation shall have One (1) directors initially. The number of directors may be increased or diminished from time to time by Bylaws adopted by the stockholders, but shall never be less than one.




