**ARTICLES OF INCORPORATION**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is HCHO, INC.

**ARTICLE II**

The existence of the Corporation shall begin on August 10, 2004.

**ARTICLE III**

The street address of the principal office of the Corporation is 600 Parkview Drive, #205, Hallandale, FL 33009

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 100, per value \$.01 per share, all of which shall be Common Shares.
