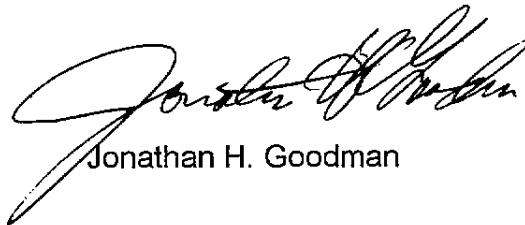

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I.**

The name of this corporation is FIRST COAST LOGISTICS, INC.

**ARTICLE II.**

The main location where the company shall conduct its business is 3536 University Boulevard, #246, Jacksonville, Florida 32277.

**ARTICLE III.**

The duration of the corporation shall be perpetual.

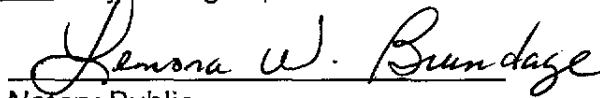
