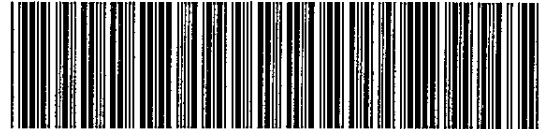



The name of the corporation is ORANGE REALTY PROPERTIES, INC.


