



**ARTICLE I**  
**CORPORATE NAME, PRINCIPAL OFFICE**  
**AND MAILING ADDRESS**

The name of this Corporation shall be: **PAUL'S LANDSCAPING OF VOLUSIA COUNTY, INC.**, with its principal office located at 110 Louisa Drive, Apt. C, Edgewater, Florida 32132 and its corporate mailing address being the same.






