



ARTICLES OF INCORPORATION

OF



BRENT DORSCH PLASTERING, INC.

<u>ARTICLE I - NAME</u>

The name of the corporation is Brent Dorsch Plastering, Inc., at 1473 Lombard Street, Palm Bay, FL 32907 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any of all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 500 shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares".

ARTICLE V - VOTING RIGHTS
