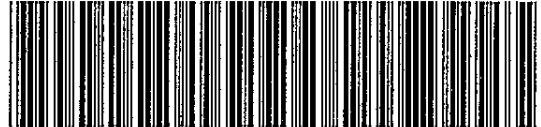

FOR

In compliance with the provisions of Chapter 607, Florida Statutes, the undersigned, for the purpose of forming a corporation, does hereby make, subscribe, acknowledge and file in the office of the Secretary of State of the State of Florida, as the Articles of Incorporation of **LUNDMAN GROUP, INC.**, a Florida corporation, the following, to wit:

Article I - Corporate Name






