ARTICLE I

NAME

The name of this corporation is MARKETING & SALES RESOURCES OF BOCA RATON, INC. The principal place of business of the corporation shall be 23229 Via Stel, Boca Raton, Florida 33433.

ARTICLE II

NATURE OF BUSINESS

This corporation is being formed for the following purposes:
