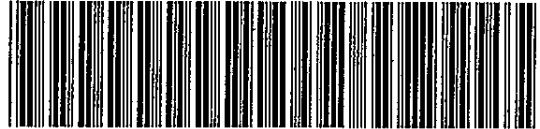

In Compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

Articles of Incorporation of All Pro Paint & Wallcovering, Inc.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of FLORIDA.

Article I: Name of Corporation

The name of the corporation shall be All Pro Paint & Wallcovering, Inc.

Article II: Nature of Business

This corporation may engage in or transact any and all lawful activities or business which may include, but are not limited to, residential, commercial and/or industrial, building, repairs, maintenance and/or improvements to real property, permitted under the laws of the United States, the State of FLORIDA, or any other state, county, territory or nation.

Article III: Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares of common stock having a par value of \$10.00 per share.

Article IV: Principal Office/Mailing Address

The mailing address and principle office of the corporation shall be 4127 Ruby Drive East, Jacksonville, Florida.

Article V: Initial Registered Agent

Article VI: Special Provisions

The stock of this corporation is intended to qualify under the requirements of Section 1244 of the Internal Revenue Code and the regulations issued thereunder. Such actions as may be necessary shall be deemed to have been taken by the appropriate officers to accomplish this compliance.

Article VII: Term of Existence

This corporation shall exist perpetually.

Article VIII: Limitations of Liability

Each director, stockholder and officer, in consideration for his services, shall, in the absence fraud, be indemnified, whether then in office or not, for the reasonable cost and expensed incurred by him in connection with the defense of, or for advice concerning any claim asserted or proceeding brought against him by reason of him being or having been a director, stockholder or officer of the corporation or of any subsidiary of the corporation, whether or not wholly owned, to the maximum extent permitted by law. The forgoing right of indemnification shall be

inclusive of any other rights to which any director, stockholder or officer may be entitled as a matter of law.

No contract or other transaction between the corporation and other corporations, in the absence of fraud, shall be affected or invalidated by the fact that any one or more of the directors of this corporation is or are interested in a contract or transaction, or are directors or officers of any other corporations, and any director or directors, individually or jointly, may be a party or parties to, or may be interested in such contract, act or transaction, or in any way connected with such person or person's firm or corporation, and each and every person who may become a director of the corporation is hereby relieved from any liability that might otherwise exist from this contracting with the corporation for the benefit of himself or any firm, association or corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.

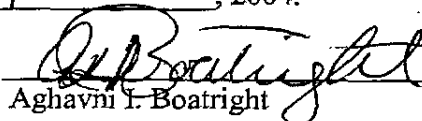
