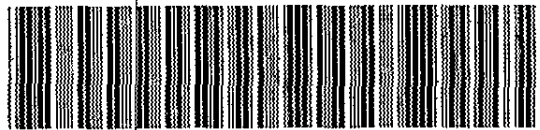

**ARTICLE OF INCORPORATION
OF
F.R.O.G. CLEANING SERVICES, INC.**

ARTICLE ONE

The name of the corporation is F.R.O.G. CLEANING SERVICES, INC. The principal address of the corporation is: 34 Aztec Blvd, Margate, Florida 33068.

ARTICLE TWO

The period of its duration is perpetual.
