**ARTICLES OF INCORPORATION

THE UNDERSIGNED, acting as sole incorporator of VERMEER ALABAMA, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of the corporation is VERMEER ALABAMA, INC.

**ARTICLE II

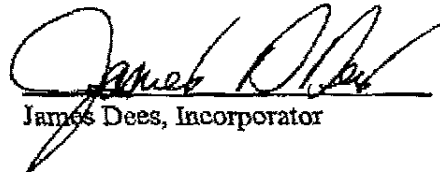
