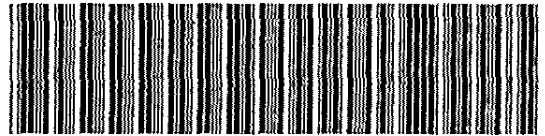

**NAME**

This Corporation shall exist perpetually.

This Corporation is organized for the purpose of operating as Trim Carpentry Company, and to operate in any lawful business.

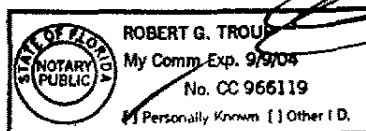

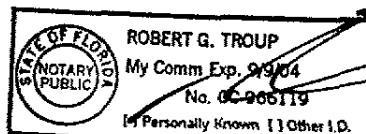
