ARTICLES OF INCORPORATION OF Thomas A. Miller, P.A. 2004 AUG 16 P 4: 55

- 1. Name. The name of the corporation is: Thomes: AITMRY IN STATE.
 TALLAHASSEE, FLORIDA
- 2. <u>Purpose</u>. The corporation may engage in the business of carrying on the brokering of real estate deals and rendering professional real estate services; provided however, the corporation may also invest its fund in real estate, mortgages, stocks, bonds or any other type of investments and may own real estate or personal property necessary for the rendering of such professional services.
- 3. Stock. The maximum number and class of shares of capital stock this corporation is authorized to have outstanding is 1000 shares of common capital stock with no par value. The corporation shall have a lien on its shares of stock for any debt or liability incurred to it by a stockholder before being notified of the transfer or levy on such shares.
- 4. Existence. The corporation shall have perpetual existence. The corporation shall commence existence on August 16, 2004.
- 5. Registered Agent. The initial street address in the State of Florida of the initial registered office of the proposed corporation is 10100 SW 186th Ave., Dunnellon, FL 34430 and the name of its initial registered agent at such address is Thomas A. Miller.

- 7. <u>Management</u>. Business of the corporation shall be managed by the stockholders.
- 8. <u>Incorporator</u>. The name and address of the person signing these Articles of Incorporation as incorporator is as follows: Thomas A. Miller, 10100 SW 186th Ave., Dunnellon, FL 34430.
- 9. <u>Affiliated Transactions.</u> The provisions of Fla. Stat. '607.0901 shall not apply to this corporation.
- 10. <u>Officers.</u> The initial officers of the corporation shall be: Thomas A. Miller as President, Secretary and Treasurer.
- 11. <u>Limitation</u>. The Corporation shall not issue any of its capital stock to anyone other than an individual who is a duly licensed real estate broker in the State of Florida to render the same professional services as those for which the Corporation was

12. Severance and Termination of Employment. Notice and Positiver, Stockholder, agent or employee of the corporation becomes legally disqualified to render the professional services for which the corporation is organized, or accepts employment that places restrictions or limitations on his or her continued rendering of such professional services, then he or she shall forthwith sever all employment with the corporation, and shall not thereafter participate or share, directly or indirectly, in any earnings or profits realized by the corporation on account of professional services. The Corporation or other Stockholders shall forthwith, upon such disqualification of any Stockholder, purchase such Stockholder's shares and pay him or her all amounts owing and lawfully due to him or her by the corporation, except that such shares shall not be entitled to dividends.
