The name of this corporation is NSI CORPORATION.

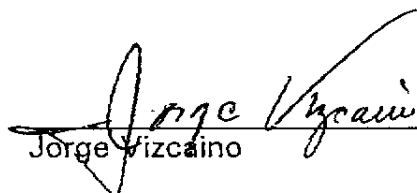
