ARTICLES OF INCORPORATION

OF

SOUTHERN BELLE LANDSCAPING, INC.

WE, the undersigned, do hereby incorporate ourselves for the purpose of becoming a corporation for profit under Florida law.

ARTICLE I

The name of the corporation is: SOUTHERN BELLE LANDSCAPING,

ARTICLE II

The corporation shall have perpetual existence.
