OF

***ARTICLE I. NAME***

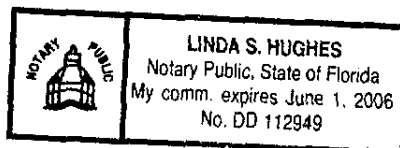
