**ARTICLES OF INCORPORATION
OF

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is Bruce Ferguson Sales, Inc. (the "Corporation"). The initial principal office of the Corporation is located at 244 Eagle Drive, Jupiter, FL 33458.

ARTICLE II. DURATION

The term of existence of the Corporation is perpetual.

ARTICLE III. PURPOSE


