### ARTICLES OF INCORPORATION OF MUSCLES IN MOTION, INC.

OHALG 17 18 1 The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida General Corporation Act.

#### ARTICLE I Name and Principal Office

The name of the Corporation shall be MUSCLES IN MOTION, INC. The address of the principal office of the corporation shall be 3130 West Lambright St., #115, Tampa, FL 33614.

#### ARTICLE II Corporate Purposes, Power and Rights

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

## ARTICLE III Duration of the Corporation

Existence of the Corporation shall commence on the date all fees are paid and these Articles of Incorporation are filed by the Secretary of State and the Corporation shall exist perpetually unless dissolved according to law.

#### ARTICLE IV Authorized Stock & Shareholder Rights

The total number of shares of capital stock which the Corporation has the authority to issue is ten thousand (10,000) shares of Common Stock, with a \$1.00 par value per share. Each holder of common shares shall have one vote for each such share held of record on all matters submitted for shareholder approval. Except as otherwise specifically required by law, set forth in a subsequently executed Shareholders Agreement unanimously adopted, or provided in these articles of incorporation, all other matters requiring shareholder approval shall require an affirmative vote of a majority of the shares voting thereon. The holders of the common shares shall have unlimited voting rights and the right to receive the net assets of the corporation upon its dissolution.

## ARTICLE V Registered Office and Registered Agent

The street address of the initial registered office of the Corporation in the State of Florida shall be 3130 West Lambright Street, #115, Tampa, FL 33614. The name of the initial registered agent of the Corporation at the registered office shall be TOM ELLIS.
