

ARTICLE I

The name of this corporation shall be . LINDO EXPRESS LINES, INC. and the initial address of this corporation shall be 11361 NW 32 Place, Sunrise, FL 33323

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
