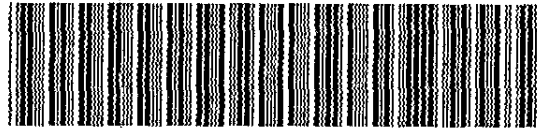

ARTICLE VII – PURPOSE


The purpose for which the corporation is organized is to engage in
