On Aug. 1, 2005, I received a letter along with my annual report saying it had not been filed due to it being received late. In the original letter that I sent on July 7, 2005, along with the report I explained how I had attempted to file and for some unknown reason according to your customer service rep. Cathy, my credit card payment had been voided in the system. I was told to mail the report and check and since I had attempted to file there would not be the \$400 late fee.

When I originally sent my annual report it was done so online thru the sunbiz website. I did so on May 2, 2005, after talking with my tax advisor who asked if I had gotten the reminder to do so. I had not gotten anything, so when I filed I checked the box saying that I hadn't gotten notice to file by May 1st. When I sent in the paper report after the online failed I did not see a box to check to say no notice was received. What I did see on the paper report above box 10, is FILE NOW!!! FEE IS \$150.00 Due by September 7, 2005. This is confusing. Is the report due by Sept. 7 or is the \$150.00 due by the Sept. 7 deadline.

Either way I did not receive prior notice to file my annual report. Once I was made aware of the need to do so on May 2, 2005, I did so immediately. Unfortunately something went wrong with the Sunbiz system and my report nor credit card payment was received, yet I have a tracking number showing the attempt was made. Due to this I don't see how I should be held responsible for the \$400 late fee you are requesting. I will be contacting my attorney about this matter as well.


So enclosed you will find a copy of the annual report that I prepared online and submitted as well as confirmation and payment pages.


