ARTICLES OF INCORPORATION

OF

DON ELLIOTT AIR CONDITIONING AND HEATING, INC.

ARTICLE I - NAME

The name of this corporation is DON ELLIOTT AIR CONDITIONING AND HEATING, INC.

ARTICLE II - PURPOSE
