OF

#### **ARTICLE I - NAME**

The name of the corporation shall be ELATIQUE PRODUCTS, INC. The mailing address for the corporation is 1834 Main Street, Sarasota, Florida 34236.

#### **ARTICLE II - DURATION**

This corporation shall exist perpetually.

#### **ARTICLE III - PURPOSE**

#### ARTICLE X - REPLACING STOCK CERTIFICATES
