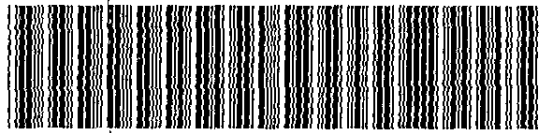

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

**ARTICLE I**

The name of the Corporation is PAINTER CARPET AND UPHOLSTERY, INC.

**ARTICLE II**

The duration of the corporation is perpetual.

**ARTICLE III**
