

ARTICLES OF INCORPORATION

OF

CAMELOT THE HORSE, INC.

ARTICLE 1. - NAME

The name of the corporation is CAMELOT THE HORSE, INC.

ARTICLE 2. - PRINCIPAL OFFICE

The principal office of the corporation shall initially be at 7873 Saddle Creek Trail, Sarasota, Florida 34241. The corporation may change its principal office from time to time as permitted by law.

ARTICLE 4. - PURPOSE

ARTICLE 10. - INDEMNIFICATION



This corporation reserves the right to amend or repeal any provisions contained in the Articles of


Incorporation, or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.


