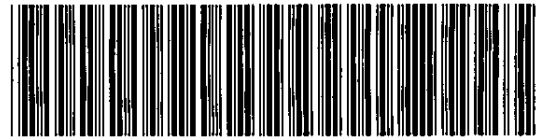

**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
ATTE CLINICAL STAFFING, INC.**

Pursuant to the provisions of Section 607.01006 Florida Statutes, **ATTE CLINICAL STAFFING, INC.**, a Florida corporation (the "**Corporation**"), adopts the following articles of amendment to its articles of incorporation, as filed on August 20, 2004:

1. Hereby added to Articles of Incorporation is a new Article XI to read as follows:

**ARTICLE XIII**

The sole purpose of the Corporation shall be provide staffing services to an assisted living facility known as "**Residential Plaza at Blue Lagoon**" located in Miami, Dade County, Florida and identified among the records of HUD as FHA Project No. 066-22092 (the "**Project**"), and to do any and all things necessary, convenient or incidental to that purpose.

Notwithstanding any clause or provision to the contrary in the Articles of Incorporation, as amended, or the Bylaws, as amended, of the Corporation, or any other document or agreement, including but not limited to any contract between the Corporation and the owner of the Project, and so long as HUD or a successor or assign of HUD is the insurer or holder of a loan secured by the Project, no material change in services provided by the Corporation to the Project or its owner may be implemented without the prior written approval of HUD.

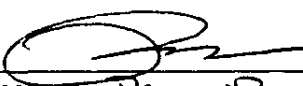
