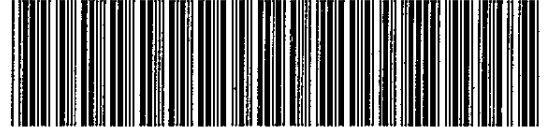


ARTICLE EIGHT
