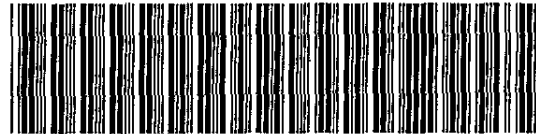


ARTICLE EIGHT
