## AMENDMENT TO THE ARTICLES OF INCORPORATION OF

#### MORE CONCEPT CORP

In accordance with the provisions of Florida Statutes Sections 607.1001, 607.1003 and 607.1006, the Shareholders and the Directors of MORE CONCEPT CORP, a Florida corporation incorporated on August 20, 2004, hereby amend the Articles of Incorporation of the Corporation as follows:

1. Article I of the existing Articles of Incorporation of the Corporation, which relates to its name, is hereby deleted in its entirety and the following new Article I shall be inserted in lieu thereof:
