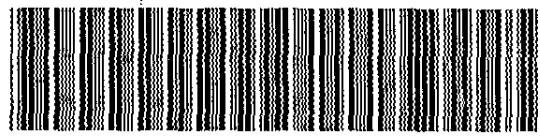

ARTICLE I. NAME AND ADDRESS. The name of this corporation shall be

ARTICLE II. DURATION. This corporation is to exist perpetually.

ARTICLE III. PURPOSE. This corporation is organized for the purpose of the

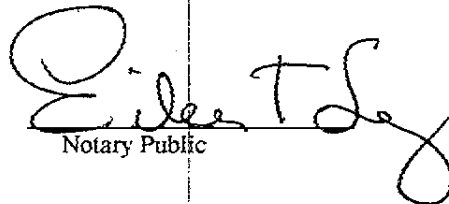
